Based on the provisions of Article 2, paragraph (2) and Article 8, paragraph (2) of the Rules of Procedure (CLASS: 602-04/21-01/226; REGISTRY NUMBER: 522-04-21-1 from October 20, 2021) and Article 3, paragraphs (1) and (4) of the Ordinance of Operation (CLASS: 602-04/22-01/26; REGISTRY NUMBER: 522-15-22-3 from January 18, 2022), Cabinet of the Center for the Study of the Relationship between Science and Religion of the Faculty of Philosophy and Religious Studies of the University of Zagreb, with the prior opinion of the Professional Collegium, adopts the following

**ACT ON THE ORGANIZATION OF THE SCIENTIFIC CONFERENCE
of the Center for the Study of the Relationship between Science and Religion**

Article 1

- (1) The Scientific conference of the Center for the Study of the Relationship between Science and Religion (hereinafter: the Center) shall be an academic gathering that promotes research of:
 - the relationship between science and religion with the aim of promoting and progressing the field;
 - the influence of religious beliefs on society as a whole;
 - the general social reach of scientific knowledge.
- (2) The name of the Scientific Conference shall be *CePOZiR Conference* (hereinafter: Conference). The serial number of the Conference and the year of its holding can be specified along with the name.
- (3) Members of the academic community and students from Croatia and abroad shall participate in the Conference.
- (4) The conference shall be held once every two years.
- (5) The working languages of the Conference shall be English and Croatian.

Article 2

- (1) The Conference shall cover three basic research areas:
 - the Relationship between Science and Religion,
 - Religion and Society, and
 - Science and Society.

Article 3

- (1) The conference shall be organized and conducted by the Boards:
 - Scientific and Program Board (hereinafter: Scientific Board), and
 - Organizational Board.
- (2) Board members shall be appointed by the Professional Collegium (hereinafter: Collegium).
- (3) Candidates for members of the Board shall be nominated to the Collegium by the Cabinet. Candidates for members of the Board may be nominated by one or more permanent members of the Collegium.

- (4) The Scientific Board shall consist of distinguished members of the academic community from Croatia and abroad.
- (5) The Scientific Board shall be headed by the President, who shall be appointed by the Collegium at the proposal of the Cabinet.
- (6) The current Head of the Center shall be the Vice-President of the Scientific Board.
- (7) The Organizational Board shall consist of permanent members of the Collegium and/or advisers of the Center.
- (8) The Organizational Board shall be headed by the President, who shall be appointed by the Collegium at the proposal of the Cabinet.
- (9) The current Deputy Head of the Center shall be the Vice-President of the Organizing Board.
- (10) The Conference may have an Honorary President. The Honorary President shall be a doyen and/or a distinguished scholar in the field of philosophy of the relationship between science and religion from Croatia or abroad. The Honorary President shall be appointed by the Head of the Center.
- (11) The Conference shall have its own spokesperson. The spokesperson can be the current spokesperson of the Center or someone appointed by the Scientific Board, with the prior opinion of the Cabinet of the Center.

Article 4

- (1) The Scientific Board shall take care of the achievement of the basic academic goals of the Conference.
- (2) The Scientific Board shall prepare the Conference program.
- (3) The Scientific Board shall perform tasks within its scope at sessions. Members of the Scientific Board can participate in the sessions via digital applications.
- (4) The Scientific Board shall validly discuss and decide when more than half of the members are present at the session.
- (5) The Scientific Board shall not make decisions if its Vice-President is not present at the session.
- (6) Decisions of the Scientific Board shall be adopted by public voting with a majority of the votes of the members present.

Article 5

- (1) The Organizational Board shall take care of the realization of the operational goals of the Conference:
 - patronage,
 - sponsorship,
 - timely announcement and advertising of the Conference, and
 - all other logistical issues.
- (2) At the proposal of the Organizational Board, the proposal(s) for patronage shall be confirmed by the Scientific Board.
- (3) The Organizational Board shall organize and manage the Technical team of the Conference, which consists of students from the Faculty of Philosophy and Religious Studies of the University of Zagreb. The Technical team shall have a Coordinator appointed by the Organizational Board.
- (4) The Organizational Board shall perform tasks within its scope at sessions. Members of the Scientific Board can participate in the sessions via digital applications.

- (5) The Organizational Board shall validly discuss and decide when more than half of the members are present at the session.
- (6) The Organizational Board shall not make decisions if its Vice-President is not present at the session.
- (7) Decisions of the Organizational Board shall be adopted by public voting with a majority of the votes of the members present.

Article 6

- (1) The Center can issue Proceedings and/or Book of abstracts of the Conference.
- (2) The Proceedings and/or Book of abstracts shall be edited jointly by the Head of the Center, the President of the Scientific Board and the President of the Organizational Board.
- (3) The Honorary President of the Conference may participate in editing the Proceedings and/or Book of abstracts.
- (4) The Center shall publish the Proceedings and/or Book of abstracts in English.

Article 7

This Act shall enter into force on the day of its adoption.
